**EXTENSION** DEADLINE OF OF REMITTANCE CONTRIBUTIONS AND SUBMISSION OF SICKNESS NOTIFICATION FOR EMPLOYERS (BUSINESS AND HOUSEHOLD)

AND COVERAGE AND COLLECTION PARTNERS (CCPs)

Pursuant to Social Security Commission (SSC) Resolution No. 535-s.2023 dated 13 December 2023, the deadline of remittance of contributions and submission of Sickness Notification (SN) for employers and coverage and collection partners affected in the multi-factor authentication/added security feature in the log-in details in My.SSS shall be extended as follows:

Deadline of Remittance of Contributions for Employers and Coverage and Collection Partners (CCPs)

Household	Contributions for the applicable months of
Employers	July, August, September or the third quarter
*	(3Q) of 2023 may be paid on or before 29

Coverage and	Contributions collection for the months of
Collection Partners	July, August, and September or the 3Q of
(CCPs)	2023 and October 2023 may be remitted on
	or before 29 December 2023.

## Provided that:

- The payment deadlines of Business Employers for applicable months after September and October 2023 and Household Employers for applicable months of July, August, September or the 3Q of 2023 as prescribed under Circular No. 2019-012 dated 06 August 2019 shall apply; and
- In case payment deadline is declared a holiday or non-working day, payment may be made on the next working day.

## II. Deadline of Submission of Sickness Notification (SN) for Employers

Contingency date	Deadline of Submission (Home Confinement)
20 October 2023 to 19 December 2023	SN must be submitted until 29 December 2023.

 The prescriptive period of filing of SN as prescribed under Circular No. 2023-008 shall apply for contingencies starting 20 December 2023.

All other existing Circulars, implementing rules and guidelines not contrary to or inconsistent with the provisions hereof shall remain valid and in effect.

This Circular shall take effect immediately following its publication in a newspaper of general circulation and registration and filing of three (3) copies of the published Circular with the Office of the National Administrative Register.
