SUBJECT

SSS-ACCREDITED COLLECTING AGENTS

I. PURPOSE

Pursuant to Social Security Commission (SSC) Resolution No. 179-s.2024 dated 08 April 2024, the list of SSS Accredited Collecting Agents accepting SSS payments is hereby amended.

II. SCOPE

All SSS-accredited banks and Remittance and Transfer Companies (RTCs) for the period **20 February 2024 to 31 October 2024**.

III. POLICIES

A. The SSS shall only accept payments from SSS-accredited banks and RTCs through the following channels:

- B. The accreditation of bank and RTCs shall be renewed upon satisfying the requirements based on the following issuances:
 - 1. Guidelines for Accreditation of Banks to Act as Collecting Agents of SSS, approved under SSC Resolution No. 582-s.2022 dated 31 August 2022
 - 2. Guidelines for Accreditation of Remittance and Transfer Companies to Act as Collecting Agents of SSS, approved under SSC Resolution No. 583-s.2022 dated 31 August 2022

IV. REPEALING CLAUSE

Circular No. 2024-001 (SSS-Accredited Collecting Agents for the Period January 24, 2024 to October 31, 2024) is hereby repealed upon issuance of this Circular.

V. EFFECTIVITY CLAUSE

This Circular shall take effect immediately following its publication in a newspaper of general circulation and the registration and filing of three (3) copies of the published Circular with the Office of the National Administrative Register.
