	<b>Query/Clarifications</b>	<b>TWG/BAC Reply</b>
1	For the similar contract, it was revised not only for corporate jackets, but we can also have it for office uniforms and fabric, right?  Is it still applicable for this bidding?	The similar contract for Lots 1 and 2 refers to fabrics for employees uniform. For Lot 3 is sewing of corporate jackets.
2	Can we request for the opening of bids from August 17 to August 21?	No. The submission and opening of bids will still be on August 17, 2023, as published.
3	Can we bid for Jackets only?	Yes. Bidders may participate in all or any of the lots they prepared to participate in.
4	How much is the bidding documents?	Costs of bidding documents for the following lots are: Lot I - ₱11,500.00 Lot II – ₱8,000.00 Lot III - ₱6,000.00
5	Is it possible to submit fabrics only then on the next stage the sketches and accessories would come in?  What if no sketches were submitted yet just the actual material, is it acceptable?	No. In the bidding documents, it is indicated in lots 1 and 2 that swatches and sketches must be submitted together with your technical proposal.  No. It is stated in the technical specifications “must submit this item”. This will serve as your proof of compliance.
6	What if you liked the design of bidder no. 1 but you liked the fabric of bidder no. 2 but not the design, how do we work around this situation?	The SSS will choose the bidder with highest combined rating based on both the design and fabric as specified in the Technical Specifications in the Bidding Documents.
7	For the Single Largest Completed Contract, what is your requirement for the previous SLCC, can we use government or private corporations?	Bidders can use the SLCC obtained from either government or private corporations.
8	What is our percentage required for SLCC?	The SLCC shall be at least 50% of the ABC per lot.
9	Would you consider Linens for fabric supplies?	No.

10	For the TOP, is it possible to have downpayment for the winning bidder?	Downpayment is not allowed. The payment term for this project is Progress Payment.
11	Is this a re-bid?	Yes.
12	May we know the reason so we can rectify the mistake?	The participating bidders were disqualified due to the following: <ol style="list-style-type: none"> <li>1. Failure to submit prototype (Corporate Jacket)</li> <li>2. Failure to indicate the specific lot no. in the SLCC/NFCC the bidder intended to participate in.</li> </ol>
13	Regarding the PTRI, do we need the proposal swatches to be approved already?	Yes. It is indicated in the technical specifications for lots 1 and 2 that swatches must already approved by the PTRI.
