This addendum/Bid Bulletin No. 1 is issued to clarify, modify or amend items in the Bidding Documents (BD) as a result of the pre-bidding conference on 05 October 2023. This shall form an integral part of the BD.

Under Section 22.5.3 of the RIRR of RA 9184, it shall be the responsibility of all those who have properly secured the BD to inquire and secure Supplemental/Bid Bulletins that may be issued by the BAC.

- Submission and opening of 2 envelopes: Thursday, 19 October 2023, 2:00 p.m. at the 2nd Floor Bidding Room, SSS Main Building, East Avenue, Diliman, Quezon City

- 3. Documentary Requirements
 - a. 1st Envelope
 - a.1 PhilGEPS Certificate of Registration (Platinum Membership).

In case of uploaded document/s, which validity period had already expired, submit the updated document/s.

- a.2 Statement of all its <u>Ongoing Government and Private Contracts</u>, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
 - For projects with Non-Disclosure Agreement, bidders are required to disclose the projects and its details using Form-05 of the Bidding Documents.
- a.3 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 50% of the ABC, completed within five (5) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, similar contracts shall refer to Supply, delivery, and installation of standby generator set with rated capacity of at least 1000kW installed in commercial establishment. SLCC should be a project without a Non-Disclosure Agreement.

- c.5 Latest Income Tax Return filed through Electronic Filing and Payment System (EFPS) corresponding to the submitted Audited Financial Statement
- c.6 Quarterly VAT (business tax returns) per Revenue Regulations 3-2005 for the last (6) months prior to the submission and opening of bids filed electronically (EFPS).
- Secretary's Certificate/Special Power of Attorney must clearly specify the name and 4. position of the authorized representative who will:

 - 4.b sign the contract (in case of award)
- Awarding shall be made to the bidder with the Lowest Calculated and Responsive 5. Bid (LCRB).
- All documents that need notarization should be notarized by the Notary Public 6. himself/herself who has the authority to do so for the current year.
