a.4 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 50% of the ABC, completed within five (5) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, contracts similar to the Projects refers to contracts which have the same major categories of work, which shall be civilarchitectural, electro-mechanical and structured cabling works as detailed in the Specifications and Bill of Quantities (BOQ)Form.

SLCC should be a project without a Non-Disclosure Agreement.

- c.5 Latest Income Tax Return filed through EFPS corresponding to the submitted Audited Financial Statement
- c.6 Quarterly VAT (business tax returns) per Revenue Regulations 3-2005 for the last (6) months prior to the submission and opening of bids filed EFPS.

## 4. Secretary's Certificate/Special Power of Attorney must clearly specify the name and position of the authorized representative who will:

#### a. submit its bid; and b. sign the contract (in case of award)

- 5. Awarding shall be made to the bidder with the <u>Lowest Calculated and Responsive</u> <u>Bid (LCRB)</u>.
