- Eligibility Requirements as stated above.
- Submit Bid Security equivalent to ten percent (10%) of the offered price for each lot you wish to purchase.

The sealed envelope shall be labelled as "Application for the Negotiated Offer to Purchase Unserviceable Properties of SSS Urdaneta Branch".

G. Evaluation of Offer to Purchase: The Committee shall evaluate all offers to purchase and validate the completeness of eligibility documents submitted at the date, time, and place set in the Invitation for Negotiated Sale. The Committee shall declare the highest eligible Offeror. The Bid Security of the winning offeror shall be considered as advance payment.
