- C. **Eligibility of Bidders:** The public auction is open to all persons except SSS employees.
- D. **Qualification of Bidder and Auction Tender Form (ATF):** Only those who attended the Pre-Bidding Conference are qualified to bid and are given ATFs.
- E. **Auction Bond:** Bidders shall submit 3 duly accomplished ATFs together in a sealed and marked envelope an auction bond in cash equivalent to 10% of the minimum auction price.
- F. **Opening of Auction Tender:** The Committee shall open all ATFs received at the time, date and place set in the ITB. Bidders or authorized representative/s shall witness the proceedings.
- G. **Evaluation of the Bids:** The SSS reserves the right to reject any or all bids without offering any reason, to waive any formality or technicality, to determine and to award to any bidder with the highest complying bid and whose proposal is deemed most advantageous to the SSS. The SSS neither assumes any obligation for any loss whatsoever that may be incurred by the bidders in the preparation of their respective bids nor does the SSS guarantee that an award will be made.
