- F. Procedure of the Negotiated Sale:
 - 1. Interested parties shall submit a sealed documentary envelope containing the following:
 - Duly accomplished Negotiated Offer to Purchase Form.
 - Eligibility Requirements as stated above.
 - Submit Bid Security equivalent to ten percent (10%) of the offered price for each lot you wish to purchase.

The sealed envelope shall be properly labeled as follows "Application for the Negotiated Offer to Purchase Unserviceable Properties of SSS Urdaneta Branch".

- 2. The Committee shall evaluate all the offers to purchase and validate the completeness of eligibility documents submitted at the date, time, and place set in the Invitation for Negotiated Sale. The Committee shall declare the highest eligible Offeror. The Bid Security of the winning offeror shall be considered as advance payment.
- 3. A post-qualification shall be done before the conferment of Notice of Award to the winning offeror.
- **G.** The winning Offeror shall be given the official Notice of Award and shall be required to pay the balance of the award price, inclusive of all government taxes, fees, or duties, if any, and all incidental expenses, to the SSS within five (5) working days from receipt of the said Notice.
- **H.** A Deed of Absolute Sale shall be executed by the Social Security System and the Awardee as soon as the award price is paid.
- I. Hauling of the Purchased Lot:
 - a. The winning Bidder shall, at his/her own expense, be responsible for the packing, hauling, and loading of the purchased lot to be done at the place indicated in the Invitation to Bid and in the presence of the authorized SSS personnel.
 - b. One-day hauling of the purchased lot shall be done on any day from Monday to Friday during office hours (8:00 AM to 5:00 PM), not later than five (5) working days from the date of signing of the Deed of Absolute Sale of the aforementioned. If hauling cannot be completed within the specified time, the winning Bidder may request another five (5) working days for hauling provided that the request is justified and in writing.
- J. Failure of the winning Bidder to haul the purchased lot within the specified period shall result to the forfeiture of the payment/bid price in Favor of the SSS.
- **K.** The winning Bidder shall guarantee the complete hauling and loading of all the property/equipment subject of the Contract without any residual remaining within the premises of the SSS.
