BOODIE'S BISTRO & CATERING SERVICES/ERP FOOD CORPORATION's quotation is within the Approved Budget of the Contract (ABC) with a total cost amounting to P130,000.00. Whereas, REMING'S EAST FOOD & CATERING SERVICES's quotation is beyond the Approved Budget of the Contract (ABC) with a total cost amounting to P156,000.00. Therefore, the lowest calculated and responsive bidder is that of BOODIE'S BISTRO & CATERING SERVICES/ERP FOOD CORPORATION .

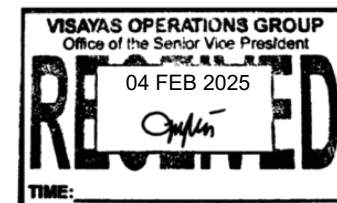
