

PNB SSS Pension Account for Foreign Nationals

It is an interest bearing Mastercard debit card supported savings account deposit product offered to foreigners who are entitled to Philippine SSS Pension.

Who are eligible:

- Foreign nationals / non-residents who have worked in the Philippines, Filipino permanent migrants with acquired foreign citizenship and overseas Filipinos.
- Have given contributions to the SSS during their working years in the Philippines, and
- Are members of SSS who are already entitled to receive long-term benefits from SSS such as retirement or survivor benefits, but are now based abroad.

What are the requirements to open a PNB SSS Foreign Pension Account

- Valid SSS number
- Valid passport, or
- Valid Government-issued Identification (ID) card with photo
- Copy of the email endorsement from authorized SSS office under the International Operations Group (IOG)
- SSS Letter of Introduction (LOI) from authorized SSS office under International Operations Group (IOG)

*PNB overseas office may require additional IDs or documents for further verification.
