For this project with Non-Disclosure Agreement, bidders are required to disclose the projects and its details using Form-05 of the Bidding Documents.

a.4 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 50% of the ABC, completed within five (5) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, contracts similar to the Projects refers to contracts which have the same major categories of work, which shall be comprised of civilarchitectural, electro-mechanical and structured cabling works, as detailed in the Specifications and Bill of Quantities (BOQ) Form.

SLCC should be a project without a Non-Disclosure Agreement.

- 4. Secretary's Certificate/Special Power of Attorney must clearly specify the name and position of the authorized representative who will:
 - a. submit its bid; and
 - b. sign the contract (in case of award)
- 5. Awarding shall be made to the bidder with the <u>Lowest Calculated and Responsive Bid</u> (LCRB).
- 6. All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year.
