For this project with Non-Disclosure Agreement, bidders are required to disclose the projects and its details using Form-05 of the Bidding Documents.

a.4 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, with supporting documents, equivalent to at least 50% of the ABC, completed within five (5) years prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be comprised of: Civilarchitectural, electro-mechanical and structured cabling works.

SLCC should be a project without a Non-Disclosure Agreement.

 - c.3 Valid Tax Clearance per E.O. No. 398, s2005, as finally reviewed and approved by the Bureau of Internal Revenue (BIR).
 - c.4 Latest Audited Financial Statement filed through Electronic Filing and Payment System (EFPS)
 - c.5 Latest Income Tax Return filed through EFPS corresponding to the submitted Audited Financial Statement
 - c.6 Quarterly VAT (business tax returns) per Revenue Regulations 3-2005 for the last (6) months prior to the submission and opening of bids filed EFPS.
- Secretary's Certificate/Special Power of Attorney must clearly specify the name and 4. position of the authorized representative who will:
 - a. submit its bid; and
 - b. sign the contract (in case of award)
- Awarding shall be made to the bidder with the Lowest Calculated and Responsive Bid 5. (LCRB).
- All documents that need notarization should be notarized by the Notary Public 6. himself/herself who has the authority to do so for the current year.
