	Query/Clarifications	TWG/BAC Reply
1	Is it all one lot with regard to the installation and delivery of SSS owned and branches?	Yes.
2	Are the locations for the unit's installation have already been identified or does the bidder need to survey first? If yes, when is the schedule for site inspection	Yes, the locations of the units for installation have already been identified in the parking and perimeters area of the selected branches. Also, the number of units to be installed per branch is already stated in the Bidding Documents. Regarding the schedule for site inspection, you may coordinate with BAC Secretariat Department. However, site visits are optional.
3	Can we have a specific number for bullet camera and dome camera needed per branch?	Please refer to Annexes A & B of the Bidding Documents.
4	May we request for plans and layout for estimating wirings and roughing-inns?	For estimate purposes, kindly refer to attached sample of CCTV layout for the large branch. For additional reference, the following are the standard areas for each branch categories: a. Small: 350-450 sq. m. b. Medium: 451-550 sq. m. c. Large: 551-650 sq. m
5	Would you take into consider a standard decibel ratio for camera?	No. the technical specifications are based on the requirements, so we retain what is stated in the technical specifications.
6	Where does the quantities for wirings and wrapping inns stated in the Bidding Documents? There is only 1 lot for Annexes A and B.	Please refer to Item A.4.
7	Regarding the NVR, are the sub owned properties and branches have an existing NVR?	Please refer to the requirements (Annex A) as there are branches that need to be installed with NVR.

	Is the new camera will be tapping to the NVR?	It depends, if the branches do not require an NVR, the new cameras will tap into the existing NVR.
8	May we know the brand of the existing CCTVs?	The existing CCTVs are Dahua.
9	In the Pre – Screening of Documents, are you pertaining to the eligibility requirements?	Yes. This is only optional if the prospective bidder/supplier want to check with BAC Secretariat the completeness of the document.
10	Regarding the eligibility requirements, if the supplier/bidder already submitted a PhilGEPS Certification, do they still need to submit copies of other eligibility documents or the PhilGEPS itself is already enough? Are the other documents will be submitted upon issuance of Notice of Award (NOA)?	No. if the supplier/bidder submitted a PhilGEPS Certificate, there is no need to submit other eligibility documents. Other documents will be required to be submitted once the bidder/supplier is found to be the Lowest Calculated Bidder (LCB).
11	Do we need to attach supporting documents for the ongoing projects?	No. We only require the list of ongoing projects.
12	Can we retype the forms in the Bidding Documents?	Yes, but make sure that there are no words or phrases that are deleted or altered.
13	Regarding Joint Venture Agreement (JVA), is it correct to assume that only one company need to be PhilGEPS certified or both parties need be certified?	No. Regarding JVA, both parties need to be PhilGEPS certified. Each partner of the joint venture shall submit the legal eligibility documents. However, the submission of technical and financial eligibility documents by any of the joint venture partners constitutes compliance.

1	Please provide Layouts and Drawings for accurate estimating of each quantities for conduits, wirings and fittings of each branch in Annexes A & B.	Please refer to Item A.4.
2	It was discussed in the pre-bid conference that the single largest completed contract must be at least 50% of the ABC.	Original SLCC requirement is retained.

	<p>We wish to highlight that the requirements to be equivalent to 50% of the ABC is unduly restrictive. This stipulation may limit the participation of various market players and could potentially lead to increased costs for the government. The imposition of this general SLCC requirement may result in the creation of a monopoly, which could contravene the objectives of public bidding as intended. Therefore, we respectfully request that you consider invoking the exception provided in the second paragraph of Section 23.4.2.2 of the Implementing Rules and Regulations (IRR) of Republic Act 9184.</p>
