

PROJECT: GARBAGE HAULING AT FCA-5 PROPERTY

A. QUERIES/CLARIFICATIONS RAISED DURING THE PRE-BID CONFERENCE:

	Queries/Clarifications	TWG/BAC Reply
1	Who will be the one to certify the driver’s license veracity, the Land Transportation Office (LTO) or our company itself?	The certification shall be issued by the company/bidder.
2	Will the garbage to be collected is already segregated?	Yes.
3	Will you provide editable forms required for the submission of bids? We notice in Section 8 that the forms presented have initials in the lower portion. Is it alright to submit a handwritten form?	We will provide the editable forms required for the submission of bids. Yes.
4	What will be the expected volume of garbage per day?	The volume of garbage varies each day, but as stated in the Bidding Documents, it can reach up to 18cubic meter. On some days, it may be more or less than 18 cubic meters.
5	Is the dump trucks really not allowed since only compactor is stated in the Technical Specification?	It is not allowed. The vehicle unit to be used must be garbage truck with compactor only.
6	What will be the basis for the SLCC?	Kindly refer to ITB Clause 5.3: Contracts similar to the Project shall be: a. Contract for garbage hauling and disposal. b. Completed within five (5) years prior to the deadline for the submission and receipt of bids. c. At least 50% of the total ABC of ₱24,090,000.00.
7	If the company is not involved in a Joint Venture Agreement (JVA), how does it transpire in the document?	The prospective bidder only needs to indicate “not applicable” in the JVA part of the form.

1	If the truck is with Deed of Sale, what documents do we need to submit?	<p>This amends Item 3.3 of the Technical Specifications.</p> <p>For trucks where the OR/CR is still in the name of the previous owner, the documents to be submitted are the following:</p> <ol style="list-style-type: none">1. Deed of Sale transferring the title of the truck to the bidder2. Official Receipt/Certificate of Registration issued by the Land Transportation Office (LTO) in the name of the previous owner. <p>For brand new trucks with no OR/CR, the document to be submitted is the Deed of Sale transferring the title of the truck to the bidder.</p>
2	The Single Largest Completed Contract (SLCC) must be a single contract under Garbage Hauling done for the past five years and must be equivalent to 50% of the ABC or P12,045,000.00 or an accumulated contracts with one client for the past five years, e.g. yearly renewal of contract?	For the SLCC, we only accept a single contract. Accumulated contracts are not acceptable.
3	<p>The garbage trucks to be used must be a compactor with capacity of 18cu.m.?</p> <p>Is it okay to use dump truck with the same capacity?</p>	<p>Yes. This amends Item 3 of the Technical Specifications.</p> <p>The Service Provider shall have a minimum of two (2) garbage trucks with compactor and minimum capacity of 18 cu.m.</p> <p>Please refer to Item A.5.</p>
4	Trucks must be OWNED by the bidder or you will consider rental of equipment?	Garbage trucks must be owned by the bidder. Rental of equipment is not allowed.
5	The certified true copy of the Driver's License and Certificate of Training will only be stamped by the bidder or by LTO or the government agency who issued it?	Please refer to our reply to Item A.1.
6	FORM – 01 which is the Bid Form, there is a clause that states “insert if foreign assisted project”, if it is not, can we not include that paragraph?	No. Please retain the statement and indicate “Not Applicable.”
7	As per instructions during Pre-bid earlier, if we opted to retype forms, do we have to retype verbatim e.g. copying FORM-03 or FORM 09 as is where is?	We will provide the editable forms together with the Bid Bulletin.

8	For the Secretary’s Certificate, we have to use your template? We cannot use our own template?	<p>We will accept the submission of a Secretary’s Certificate not using the SSS template, as long as the required information, such as the authorized signatory and representatives, are indicated in the document to be submitted.</p> <p>Additionally, we strongly advise the bidders to pattern their Secretary’s Certificate with the template provided in the Bidding Documents.</p>
