TO : ALL SSS MEMBERS AND EMPLOYERS
SUBJECT : SSS-ACCREDITED COLLECTING PARTNERS

I. PURPOSE

In line with the accreditation and renewal of accreditation of banks and RTCs accepting SSS payments, the list of SSS-accredited collecting partners is hereby issued.

II. SCOPE

All SSS-accredited banks and RTCs for the period **22 August 2025 to 31 December 2026**.

III. ABBREVIATIONS AND TERMS

1. Accreditation	Process of designating a bank or an RTC to act as collecting partner of SSS
2. Bank	Universal, commercial, thrift, rural, cooperative, digital, and other banks, as licensed by the Bangko Sentral ng Pilipinas
3. SSS Payment	Contributions, loan amortization, and other SSS-related payments by SSS members and employers, which a bank or RTC is authorized to collect under the E-Collection Service Agreement

TERM	DEFINITION/DESCRIPTION
4. RTC	Any entity that provides Money or Value Transfer Service, including Remittance Agent, Remittance Platform Provider, E-Money Issuer, Operator of Payment System, and Pawnshop

V. REPEALING CLAUSE

Circular No. 2025-002 (SSS-Accredited Collecting Agents) dated 03 February 2025 is hereby repealed upon issuance of this Circular.

This Circular shall take effect immediately following its publication in a newspaper of general circulation and the registration and filing of three (3) copies of the published Circular with the Office of the National Administrative Register.
