**H. Submission of Bids:** Bidders shall complete the appropriate portion of the BTFs and submit together in a sealed envelope a bid bond in cash equivalent to 10% of the amount of bid.

**I. Opening of Bids:** The Committee shall open all bids received at the time, date and place set in the Invitation to Bid. Bidders or their authorized representative shall witness the proceedings.

Evaluation of the Bids:** The SSS reserves the right to reject any or all bids without offering any reason, to waive any formality or technicality, to determine and to award to any bidder with the highest complying bid and whose proposal is deemed most advantageous to the SSS, provided the offer is not less than the minimum bid price.
