## **BRIEF DESCRIPTION OF FUNCTION**

Commissioner Limlingan was appointed as Social Security Commission (SSC) member, representing Employer's group on November 19, 2024 and took his oath on November 25, 2024.

As a member of the SSC, which serves as the governing body of the Social Security System (SSS), Commissioner Limlingan plays a crucial role of governing the SSS administration in terms of policymaking, policy direction, monitoring and overseeing management actions. He is responsible for formulating policies to ensure effective management and protection of members' benefits, approves guidelines for contributions, fund investments, and benefit disbursements, and monitors operations to align with the SSS mission of providing social protection.

Additionally, the SSC safeguards the sustainability of funds to meet the needs of members and their beneficiaries, ensuring efficient, effective, and transparent operations. He is also performing quasi-judicial functions through the decisions rendered in the evaluation of cases involving disputes on SS coverage, benefits, contributions and penalties pursuant to Republic Act No. 11199 otherwise known as The Social Security Act of 2018.

In January 2025, he was designated as Chairperson of the Risk Management and Actuary Committee (RMAC), and a member of SSS Investment Committee, Contribution and Collection Committee, and Corporate Governance Committee.

## **MAJOR ACHIEVEMENTS**

With a diverse career in finance, investment, public service, and entrepreneurship, Commissioner Limlingan has contributed to strengthening economic governance and financial management in the Philippines.

As a Member of the Social Security Commission (SSC) and former Board Member of the Development Bank of the Philippines, he has been involved in overseeing risk management, investment strategy, and policy implementation to safeguard public funds and drive economic growth.
