BRIEF DESCRIPTION OF FUNCTION

As a member of the Social Security Commission (SSC), which serves as the Governing Board of the Social Security System (SSS), Commissioner Aguilar shares in the responsibility in the governance of the SSS in terms of providing policy directions, monitoring and overseeing management actions pursuant to the powers and duties granted under Republic Act No. 11199 (Social Security Act of 2018). She also performs quasi-judicial functions through the decisions rendered in the evaluation of cases involving disputes on SS coverage, benefits, contributions and penalties of which fall under the exclusive jurisdiction of the SSC.

Commissioner Aguilar is the Chairperson of the Investment Oversight Committee. She is likewise a member of the Audit Committee, Contributions & Collection Committee, Benefits, Collection & ESG Committee and Governance Committee.

As Chairperson of the SSS' Investment Oversight Committee, Commissioner Aguilar sets the direction in making strategic initiatives and policy reforms which contributed to generating a higher ROI in the investment performance of the SSS.
